Application and dosage



Foam Drizzle[®] Red SP 10 onto surfaces, clean with a suitable cleaning cloth and rinse with water.



Note

Rinse afterwards with clean water. Foam must not be applied directly to chrome fittings – allow product to foam on a cleaning cloth. Rinse afterwards with clean water. Do not use of calciferous natural stone surfaces such as marble, Solnhofen slab, travertine and shell limestone. Do not use on aluminium, lacquered surfaces and acrylic glass. Changes or variations in colour do not impact on product quality.
