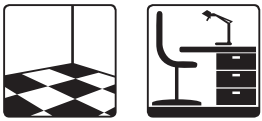

### Application and dosage



Daily routine cleaning:  
100 ml / 10 l water



Intensive cleaning:  
100 - 1000 ml / 10 l water



Single-disk machine:  
500 - 1000 ml / 10 l water



Machine cleaning:  
100 - 500 ml / 10 l water



High-pressure cleaning:  
1:5 to 1:10 with water

### Note

Always use cold water.

Rinse with clean water.

When being used in the automat, the tanks should be regularly cleaned and rinsed. Changes or variations in colour of the product do not impact on the quality.
